ROSS POINT REGULATIONS

All attendees must abide by the Ross Point policies and procedures, both verbal and posted.

- 1 No smoking is permitted in any building. Designated smoking areas are the main parking lot, below the dining room deck, and the front porch of Shoreline and Edgewater, away from all non-smokers.
- 2 No alcohol or illegal drugs are allowed. This includes all forms of cannabis.
- 3 Gum is not permitted.
- 4 No pets allowed.
- 5 Meals are served family style. Attendees are expected to help clear individual tables after each meal. Promptness to meals is essential.
- 6 Vehicles must be parked and locked in designated parking areas. Guests must move their vehicles to the designated areas after loading and unloading.
- 7 Quiet time is between 10:00 pm and 6:00 am and everyone should be as quiet as possible, respecting the privacy of neighbors.
- 8 Ross Point assumes no responsibility for lost & found, or stolen items.
- 9 At the end of each use, the last one out of a room should turn off lights. At the end of your stay, return furniture to its original position, close doors and windows, turn off lights, and turn down heat.

COVID POLICY FOR SHUTTLEBIRDS TATTING GUILD 2022 WORKSHOP

In consideration of the services of **Shuttlebirds Tattling Guild**., their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf, I hereby agree to release, indemnify, and hold harmless Shuttlebirds Tattling Guild , on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that my participation in any event conducted by **Shuttlebirds Tattling Guild** such as a camp, conference or retreat event entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be completely eliminated without jeopardizing the essential qualities of the activity. **The risks include, among other things:** coming into contact with people who may have had or currently have a communicable disease such as COVID-19, slips, falls, pinches, scrapes, twists and jolts that could result in scratches, bruises, sprains, lacerations, fractures, concussions, or even more severe life-threatening hazards. During camp, a retreat or conference, there may be contact with other people, plants, animals, or insects that could create hazards such as stings, allergies, and associated disease.

2. I expressly agree and promise to accept and comply with the infection control practices currently in effect by the Centers for Disease Control (CDC), State of Washington, State of Idaho and or Federal Government currently in effect as of the date of the event attended.

These measures shall include and are not limited to the following practices;

- Wearing a mask or face shield indoors
- Proof of vaccination or a negative PCR test within 72 hours of event
- Frequent hand washing and use of hand sanitizer
- Maintaining a safe social distance

My participation in this event is purely voluntary, and I elect to participate in spite of the risks.

3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Shuttlebird Tattling Guild from any and all claims, demands, or causes of action, which are in any way connected with my participation in this event or my use of Shuttlebird Tattling Guild's equipment or facilities, **including any such claims which allege negligent acts or omissions.**

4. Should **Shuttlebirds Tattling Guild** or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

5. I certify that I have insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage to myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have, and I am willing to assume -- and bear the costs of -- all risks that may be created, directly or indirectly, by any such condition.

6. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
